Knights that recognize a specific need or interest are encouraged to bring forth a challenge to council members to perform acts of charity that will foster unity and fraternity while being consistent with the precepts of the Faith in Action Program. These challenges provide opportunities to the council membership for contributions of their time, talents, or treasures.

The Process – In order to propose a challenge to the council and membership, it is most appropriate and important to present the proposal to a council officer or attend an Officer's Meeting. If the meeting is in virtual format, contact an officer for the meeting link. Presentation of the proposal will provide the officers with an opportunity to understand the exact parameters of the proposal, ask questions, and establish the proposal as an agenda item for an upcoming meeting of the general membership. The general membership must be given an opportunity to vote on the proposal. If the proposal is approved by the membership, it will be the responsibility of the presenter to bring the proposal to fruition.
